RECENTLY DECIDED CASES

Verzone v. State
Court of Criminal Appeals
Released June 28, 2002

The defendant appealed her guilty plea alleging that it was not voluntarily entered. The Court of Criminal Appeals reversed stating that where the trial court failed to hold a plea colloquy in connection with the <u>Ireland</u> form, the appellate court was unable to determine the voluntary nature of the plea and therefore the plea must be set aside.

Phelps v. State
Court of Criminal Appeals
Released June 28, 2002

Although the Court of Criminal Appeals affirmed Phelps conviction for distribution of a controlled substance, the interesting portion of the opinion appears in the concurrences written by Justices Cobb and Shaw. Both Justices believe that the enhancements under section 13A-12-250 and 13A-12-270 must be charged in the indictment and proved beyond a reasonable doubt at trial before they can be applied in accordance with Poole decided last year.

Davis v. State
Court of Criminal Appeals
Released June 28, 2002

Davis appealed his conviction for distribution with enhancements under 13A-12-250 and 270. The court of criminal appeals affirmed the conviction and enhancement under 13A-12-250 but reversed the enhancement under

13A-12-270 ruling that the public housing project must be owned by a public housing authority for the enhancement to apply. In Davis' case the housing project was privately owned.
